

## How do I register a solar panel?

## How do I register for a solar PV scheme?

You must register with SEAIas a company or installer for the Solar PV Scheme. The domestic SPV Scheme has two types of registered professionals. If you are applying to register on the domestic solar PV scheme you can register as a Company,register as an Installer or register as both.

## What if I don't register my solar panels?

If you're a shared owner or a homeowner and you haven't registered your solar photovoltaic (PV) panels, and they were installed after 14 January 2016,you can apply to your electricity supplier to get the 'Feed-in tariff' (FiT) payments. This is in effect a grant from the Government according to how much electricity your panels are generating.
