#### What is energy storage Ireland?

Energy Storage Ireland is a representative association of public and private sector organisations who are interested and active in the development of energy storage in Ireland and Northern Ireland. Delivering the energy storage technologies to enable a secure, carbon free electricity system on the island of Ireland by 2035.

## Will Ireland develop a policy framework for energy storage?

Image: Iberdrola. The Irish government has launched a consultation to help direct the development of a policy framework for energy storage. As the renewable energy generation market continues to grow in Ireland there is an increasing urgency to develop energy storage solutions in a bid to provide flexibility to the energy market.

## How much does EirGrid's storage contracts cost?

Eirgrid has estimated the total value of the contracts at around EUR6 million per year. Eirgrid is using storage to work towards a 75% renewables power network in the near future. Irish grid authority Eirgrid Group has selected three large scale storage projects, with a combined capacity of 110 MW, in the first auction held under the DS3 program.

#### What is the tender advisory service?

The Tender Advisory Service (TAS) was established by the Office of Government Procurement (OGP) to address concerns for SMEs in relation to perceived barriers for competing for tender opportunities.

What is EirGrid's Renewables Initiative?

The initiative has enabled the Irish electricity grid to raise the contribution of renewables from 50% to 65%, a level Eirgrid describes as a "world first", and with the further aim of reaching 75%. The storage tender held on September 24 was intended to allocate around 140 MW of capacity.

## How much does EirGrid's T-4 capacity auction cost?

EirGrid assigned 7.2 GW of capacity in its latest auction, with 5.4 GW to come from gas power plants. The auction clearing price reached EUR83.050 (\$90.554)/MW per year. Irish grid operator EirGrid has published the provisional results of its latest auction for the capacity market - the so-called T-4 Capacity Auction.

In a bid to incentivise the creation of energy storage in Ireland, the government is developing a policy framework to help deliver their objectives in this area of its Climate Action Plan which is targeting a proportion of ...

The Innovation Tender solicitations were launched in 2020, and are open to project bids that combine two or more renewable or clean energy technologies. To date, it has seen only bids for solar PV and battery projects,

Dubai Electricity and Water Authority has launched a tender seeking Independent Power Producer (IPP) advisory services for a large-scale renewable energy project in Dubai. The initiative involves a 1.6 GW solar photovoltaic (PV) power plant paired with a 1,000 MW Battery Energy Storage System (BESS), designed to provide six hours of storage.

The solar farms in Ardnadoman, Dromsallagh and Rooaun are part of six projects - with a cumulative capacity of 60 MWp - awarded under the Renewable Energy Support Scheme (RESS) 3 auction in 2023. Construction of the initial three solar farms is expected to begin in January 2025, with a projected commissioning date of the second half of 2025.
