#### What are the tax rules for electricity installation?

There are two different sets of tax rules, depending principally on whether the installation is domestic or commercial. The contract documentation will state the type of installation. A domestic installation is normally mounted on the farmhouse roof (occasionally in the garden) and provides electricity solely to the dwelling.

#### Do solar installations qualify for HMRC tax relief?

HMRC regard solar installations as a long-life asset, which sometimes reduces relief. However, the installations do qualify for 100% Annual Investment Allowance(which is available for up to £1,000,000 of total qualifying expenditure by most standalone farming sole trades, partnerships or companies in the year ending 31 March 2023).

### Are solar home lighting systems covered under GST?

The Applicant submitted that the supply of Solar home lighting systems is coveredunder the 'Solar power based devices' vide Sl. No. 201A of Schedule II of Notification No. 1/2017-Central Tax (Rate) dated June 28,2017 ("the Goods rate notification"). Issue: What is the appropriate classification of Solar home lighting systems under GST? Held:

## Is a commercial solar installation eligible for capital allowances?

Installations on farm outbuildings (or in fields), which supply electricity to the farm (on its own or in conjunction with the house) or to multiple properties, are commercial. Commercial installations are usually larger than domestic ones. The cost of a commercial solar installation is eligible for capital allowances.

### Does solar home lighting attract GST?

Solar home lighting systems attracts GST @12%The AAR,Uttar Pradesh,in the matter of M/s. R2V2 Technologies Private Limited [Advance Ruling No. UP ADRG 27/23 dated May 08,2023]ruled that solar home lighting systems are appropriately classifiable under tariff entry 9405 5040 and accordingly will attract GST @12%. Facts: M/s.

### Are electricity sales taxable?

This includes both sales of exported electricity and any Feed in Tariff Any income from a domestic installation at a let dwelling is taxable(even though capital allowances are denied). The principal incentive for residential landlords is to improve the EPC rating (but your tenant will appreciate the lower energy costs).
