How do I become an EU exporter?

As an EU exporter you need to apply at the competent customs administration for a so-called Economic Operators Registration and Identification (EORI) number. The EORI is an identification number that is valid throughout the EU, which you need for all customs export declarations. Tip: This process can take some time so apply well ahead.

What qualifications do I need to work in international trade?

Level 1 and 2 qualifications are equivalent to GCSEs and Level 3 is the same standard as an A Level. No formal qualifications are required for these courses.
